MEETING CALLED TO ORDER

ADOPTION OF MINUTES

 <u>November 10, 2017, Town Council Executive Session</u> - A motion was made by Councilmember Shaw, seconded by Councilmember Boteler, to accept the November 10, 2017, Town Council Executive Session Minutes.

Discussion: Councilmember Callaway stated that she does not think the minutes adequately express the substance of the conversation/discussion at the November 10, 2017, Town Council Executive Session so she will be voting no on approving the minutes. Councilmember Stevenson agreed.

Mayor Voveris called for a roll call. The voting was as follows:

 <u>November 17, 2017, Town Council Public Hearing on Ord. 188-17</u> - A motion was made by Councilmember Shaw, seconded by Councilmember Saxton, to accept the November 17, 2017, Town Council Public Hearing on Ord. 188-17 Minutes. The motion was unanimously carried.

November 17, 2017, Town Council Regular Meeting

Motion: A motion was made by Councilmember Shaw, seconded by Councilmember Boteler, to accept the November 17, 2017, Town Council Regular Meeting Minutes. (No vote was taken on this motion.)
