FROM THE MAYOR'S DESK TIM SAXTON

Bethany. We were fortunate to have had beautiful summer weather that allowed our residents to enjoy our beach and recreation in our canals. Our staff and volunteers held two very successful events this summer, a movie on the beach and our 50th Anniversary celebration.

On June 30 we had a very successful celebration of the 50th Anniversary of the Incorporation of South Bethany. The entire Town staff and a multitude of volunteers worked many hours to assure a wonderful afternoon for owners and visitors to learn about our Town and enjoy friendship. The Cornhole Tournament went on for many hours and it was obvious all teams enjoyed their participation. I want to thank all of the staff, volunteers and vendors that contributed to the day's success as it will be something all of us will remember.

Since the last Zephyr, the Town Council has taken continued actions to grow and improve our South Bethany Police Department. In June a new Chief of Police, Chief Lovins, joined the Department. In his first four months, the Chief has been very active in improving the Department. Some of the steps taken to date are:

- Along with Sergeant Wiley, assured the completion of COPT certification for Officer Klopp.
- Hired a new Officer, Shaun Baldasano.
- Officer Fullerton has completed the Delaware State Police Academy and is currently completing Field Training.
- · Sponsoring a recruit, Anthony Quiroz, to attend the Delaware State Police Academy this fall. When this Officer graduates the department will be at full staff.
- Implemented multiple software applications to improve the efficiency of the officers and reporting.
- Initiated work on improving Departmental Policies.

The summer of 2019 has passed, and fall has finally arrived in South These changes reflect the commitment of our Chief and Town Council to have a fully staffed, cost-effective and efficient South Bethany Police Department to serve the property owners of the town.

> The Town continues to focus on the bicycle and pedestrian safety on Route 1. Recently South Bethany and Bethany Beach agreed to partner in working with DelDOT to provide improvements along Route 1. Fenwick Island and North Bethany have asked to be included in these discussions. Our goal is to improve the safety from the Indian River Inlet to Fenwick Island. We will keep our owners informed of the progress we make in working with DelDOT.

> As we move into the off season, we will begin to work on the initiatives that were passed in the FY 2020 budget so completion occurs by the end of the fiscal year. The Town has been working on the specifications for improved beach pedestrian walkways with the expectation of the bidding process to begin in November. Similarly, bidding for road repairs for Bristol Road will be initiated shortly with the anticipation for the project to be completed in the spring.

> For the summer of 2020, parking permits will be required on designated streets on the west side of Route 1. Currently the Town Manager and Chief of Police are putting the plan together for the exact locations. This plan will be announced as soon as it is available, and signs will be put in place by next April.

> Financially the Town continues to be in a solid position. Through the first five months of the year our revenues and expenses are tracking to budget expectations. Use of our capital budget remains on schedule for FY2020 with many of these capital expenses planned for the off season.

> Lastly, enjoy the off-season activities of coastal beaches and remember to prepare your homes for the winter season.

Coastal Towns Historic Village 3rd Annual Cottage Tour In South Bethany Saturday, October 12, 2019



SNOW REMOVAL TIPS

As a reminder, when winter rolls around and if plowing Town-owned roads becomes necessary, the Town is not responsible for maintaining private walkways or plowing private driveways. Please make arrangements with a snow removal contractor. Look in the local newspapers or online for advertisers prior to the snow season.

To lessen the chance of shoveling your driveway twice, here are a few tips, along with a diagram.

- Create a 'landing strip'. Clear an area before the driveway where snow accumulated on the plows can land.
- Go with the flow. Shovel snow in the same direction as traffic and pile snow downstream of the driveway.

- Did you know that repairs, renovations, remodeling, and many other activities require permits both from Sussex County and the Town of South Bethany? Before you start any project please call 302-539-3653 x 211 to see if your project requires permits.
- To improve drainage on your property and have a firm walking surface, consider installing pervious pavers instead of concrete or asphalt.
- If you have questions regarding Elevations, Flood Maps, or Flood Risks please call my office and I will assist you with the information we have on file for your property.
- Consider getting a <u>NEW</u> Elevation Certificate. Insurance companies and FEMA use Elevation Certificates as a tool in determining your individual flood risk. Old Elevation Certificates may have used outdated benchmarks that are now unacceptable for rating properties. For help understanding the Elevation Certificate please visit this link. - IF YOU ARE UNDER A FLOOD WARNING, FIND SAFE SHELTER RIGHT AWAY. Do not walk, swim, or drive through flood waters. Turn Around, Don't Drown!

As the fall and wintertime season approaches here are some reminders regarding our Town Code:

- <u>Vegetation</u> It has been a great year for the plants and grasses but we need to be ever aware not to create a safety hazard for the Town. Please take time to look over your property to see if your plants or trees might be unsafe or creating a traffic hazard for you or your neighbors. The code for these items is included here for convenience. 104-12 states the following:
 - A. Vision clearances. The owner of a corner property shall maintain adequate vision clearance at corners by not allowing plantings, shrubbery, bushes, or other vegetation or beautification mounds, including their vegetation, to exceed three feet in height above the grade of the street surface within 10 feet of the intersection of the right-of-way lines of the two streets in accordance with the provisions of §§ 145-9 and 145-13.

- B. **Encroachments**. No property owner shall allow any bush, shrub, tree, planting or other vegetation to encroach onto, or into, the streets, alleys, canals, or other Town rights-of-way in accordance with § 125-2 of this Code.
- C. **Underbrush; dead wood**. All lots shall be kept free of dead trees and accumulations of invasive or noxious vegetation. All lots shall be kept free of unreasonable accumulations of underbrush, limbs, and branches as would constitute a fire or health hazard.

Some wintertime tips:

- Keep gutters clean of tree debris to promote proper roof drainage. If gutters are clogged, damage to the fascia boards, interior leaks in walls and the growth of mold and mildew can occur in a very short time.
- 2. When ice and snow cover concrete driveways and sidewalks avoid using salt based ice melting products. Salt is very damaging to concrete. Instead try using a calcium or magnesium based ice melt product. These products melt ice and snow very quickly and are less hazardous to the environment.
- 3. Consider a home energy evaluation. For more information about how this can save you money visit this handy website: https://www.energy.gov/energysaver/heat-and-cool/home-energy-audits
- 4. Now is a good time to check your smoke detectors. Smoke detectors like most things require maintenance and it is recommended to test them monthly. Did you know that having working smoke detectors properly installed increase your chances of surviving a fire by almost 50%?
- Have all fuel burning equipment tested and serviced by a professional.
- 6. Make sure your dryer vents are clear of lint. Blocked vents can often lead to fires in the house.
- 7. Consider installing a CO detector. Carbon monoxide is an odorless, tasteless and toxic gas. CO can kill you before you are aware of it in your home. At lower levels CO causes mild effects that are often mistaken for the flu. The effects of CO exposure can vary greatly from person to person depending on age, overall health and the concentration and length of exposure. CO originates from many sources such as, but not limited to, leaking chimneys and furnaces, gas water heaters, wood stoves and fireplaces to name just a few.
- 8. Finally, keep all important phone numbers in a place easily accessible in case of emergency.

RENTAL TAX DUE OCTOBER 31, 2019

Rental taxes shall be due and payable to the Town no later than Oct. 31 of each year and shall cover the prior period of Oct. 1 to Sept. 30. Rental Tax remains at 8% of total gross receipts collected for each residential and commercial property.

NO WAKE ZONES

All waterways from our canals to the Little Assawoman Bay are posted "NO WAKE" zones. If you see a boat creating wake in our canals, make a downward motion with your hand. If the boater chooses to ignore your request to cut the boat speed, you have the right to take pictures and capture the boat's name, boat description, and its registration number and then contact DNREC's Boat Enforcement Division at 302-739-4580.

HELP KEEP OUR BEACH AND TOWN CLEAN

Dog excrement has been seen along the beach. Everyone is asked to clean up after their dogs and not dispose of dog excrement in someone's private trash container. Please adhere to these Town ordinances:

§ 30-5. Removal of excrement. The owner shall carry and use a bag or other device to pick up and remove any excrement said dog shall drop on property other than their own.

§ 114-5E. It shall be unlawful to place or deposit any animal excrement into any cart, bin, can, or container that is not the property of the animal owner or the Town.

Properly winterize your home — we receive many calls for frozen pipes. Also prepare for storms — remove or secure all outdoor items. Boats also need to be secure.

To report a broken water pipe, please call Artesian's Customer Service Number: 302-453-6930. You will need to give the Customer Service Representative the property address. Artesian's inspector will go to the property and take care of the issue. Please note, Town Staff is not permitted to access private properties.

To avoid frozen water pipes, please properly winterize your home.
