Police - Chief Jason Lovins (see att'd report)

- The Department's activity is as follows:

- South Bethany Police Department applied for and was granted 116 hours of overtime paid for from the Delaware Office of Highway Safety. This overtime focuses on speeding, pedestrians, and DUI enforcement on Coastal Highway.
- South Bethany Police Department is still investigating drug trafficking after an officer seized a very substantial amount of heroin during a traffic stop on Coastal Highway.
- The new Watch Guard MVR/BWC (in car and body cameras) have been purchased and delivered. Installation and a departmental policy for BWC's is on target to be implemented by the end of August.
