If permit is granted, I/we agree to comply with all the following conditions:

1. The above stated roadcut/bore shall be restored to its original state **within 90 days** of project completion. **Final restoration will be reviewed and approved by the Public Works Lead and/or Code Enforcement Officer.**
2. That traffic will be maintained at all times, unless permission is granted by the Public Works Lead to do otherwise. Contractor will be responsible for notifying the Town, specific property owners being affected, and all emergency personnel if closing the road is deemed necessary.
3. Necessary lights, signs, barricades, flagmen and watchmen will remain onsite throughout the project for the protection of motorists and pedestrians, during the work provided under this permit. Permit holder assumes all responsibility to provide said safety devices when needed.
4. Dirt/fill from the construction site must be removed and not placed in any ditch or roadside swale.
5. If the roadway pavement is damaged either by construction, construction equipment or by excessive weight the Applicant is responsible for complete restoration, as indicated on this permit and accordance with DelDOT specifications.
6. If the test and/or excavation hole is less than 144sq-in (1ft by 1ft) then the repair shall be only the size of the hole. The fill shall be compacted in lifts, and the same amount of stone, hot mix, concrete, etc.- as the existing roadway shall be replaced. If test and/or excavation hole is larger than 1ft by 1ft than the hole must be filled with borrow type C in 8" lifts, 12" min of BCBC in 6" lift **or** 8" min of class A concrete and with a min of 2" type C hot mix (thickness to match existing hot mix) as shown on the attached P-4 detail, or to the satisfaction of the Town of South Bethany.
7. No construction or job site material such as dumpsters, stone, wood, building material, etc., may be stored on any Town of South Bethany roads.
8. If the permit expires before project completion, the Applicant must re-submit a new application with the Town.
9. Town of South Bethany Mercantile License required for all contractors and subcontractors.
